The PhD admission test will be conducted on the advanced knowledge of English literature, Language education and linguistics. Following is the indicative list of areas, topics and themes for reference.

Module VIII: Literary Theory & Criticism

This module on Literary theory and criticism offers an in depth exploration of the influential critical approaches shaping the study of literature today. It spans a wide range of theoretical frameworks, from Classical to contemporary, including Indian Aesthetics and Theories, New Criticism and Formalism, Marxism, New Historicism, Psychoanalysis, Feminism, Structuralism, Poststructuralism and Deconstruction, Postcolonialism and Subaltern Studies and, Race and Caste Criticisms. Students will engage with foundational texts and methodologies that questions how literature engages with different cultures, histories and societies. Emphasis is placed on enabling and facilitating the development of sophisticated and nuanced interpretative skills to foster original research. This module will also cultivate a critical understanding of the evolving relationship between theory and practice which will prepare the students to challenge the conventional boundaries of literary analysis while contributing to the academic discussions in the field.
